INFORMATION

- You are advised to read The Association's 'Conditions of Hire' before completing this form.
- Please use a separate form for each Waterway Holiday you book.
- The *Madam Butterfly* can accommodate up to 7 people (including the bunk adjacent to the disabled person's bed).
- For safely handling the boat, your party must include two able bodied crew in addition to any people needed to provide for the care needs of the disabled person(s).
- Hiring's begin at 4pm on the Start Day and the boat is to be vacated by 10am on the End Day.
- Car parking for one vehicle is available without charge. Subject to availability, additional vehicles may be parked at £10 per vehicle per week, payable to our Agent when you arrive at the Boatyard.
- All Hirers may benefit from a Cancellation Scheme in accordance with the Conditions of Hire but this cover cannot operate in respect of any member of your party whose details are not given in the Hirer's Declaration below.
- For confirmation of booking after making a provisional reservation, please complete this form and send it with payment of the deposit of £200.
- The £200 deposit is non-returnable in event of cancellation.
- This booking form and the deposit payment must reach the Bookings Manager within two weeks of making your provisional reservation, or your reservation will be cancelled.
- You will be required to pay the balance of Hire Fee, plus a returnable Security Deposit of £100 by a separate cheque, at least six weeks before your holiday.
- The Security Deposit cheque will not be banked before your holiday. Provided the boat is returned undamaged and on time at the end of the holiday in accordance with the 'Conditions of Hire', this cheque will be returned to you within 14 days of the end of your holiday.
